- 1. FROZEN SEMEN FEES:** Frozen semen fee is \$175 per breeding/ICSI dose.
- 2. CONTAINER RETURN:** Shipment container must be returned within 5 working days of receipt by the Customer at the Customer's expense. A \$30 per day late fee will be charged for any container not received within 5 working days. If the shipment container is not returned after 3 weeks, a charge of \$1500 will be charged to the Customer's credit card.
- 3. OTHER FEES:** The Customer will be responsible for the cost of the semen shipping process, including lab fees, container liability, LN Vapor Charge, USDA, export, and transportation fees.
- 4. CARRIER:** Standard shipments will be sent by Federal Express Priority Overnight Delivery unless a different request is made. The Customer will be responsible for the charges. If you would like to be billed for third party shipping please fill out your 9-digit Fed Ex number in the designated space. All shipments **MUST** be insured for shipment to mare owner and for shipment back to the stallion owner. All frozen semen shippers will include a return label. These shipments must be returned through Federal Express (Fed Ex) **ONLY**. Counter to Counter shipments are \$500 and must be paid prior to shipping. Stone Equine LLC is not responsible for any damages once the shippers have been dropped off with the airline or FedEx carrier.
- 5. FEE SCHEDULE:** A credit card must be on file before the first shipment. Payment of fees in paragraph 1, 2, 3, and 4 will be due in full within 30 days of invoicing date. A surcharge of 3% will be used on all credit card transactions. For faulty credit cards, a late fee of \$10.00 per day will be assessed. Customers whose payments are in excess of 30 days past due shall also be in breach of contract resulting in the termination of service for Customer's mare and foal registration.
- 6. UNUSED BREEDING STRAWS:** Customer must notify Stone Equine LLC of any remaining semen straws. All frozen straws are to be returned to Stone Equine LLC.
